Short sleep duration and chronic stress associate with elevated inflammatory cytokines in controlled studies. Improving sleep consistency to 7-9 hours and incorporating brief daily breathing practices show small but replicable reductions in perceived stress and some biomarkers, with stronger data for sleep than for stress interventions alone.

Practical takeaways

- Aim for at least five servings of vegetables and two of fruit most days and track weekly averages.
- Schedule 150 minutes of moderate movement across the week and log sessions to maintain consistency.
- Target a fixed bedtime window differing by no more than 30 minutes nightly and review sleep data monthly.
- Practice a 5-minute breathing routine daily and note subjective stress levels on a 1-10 scale.
- Reassess habits with a clinician if new symptoms appear or routine bloodwork shows unexpected changes.
